Mummi trahter is an imaginary part of the property as joint ownership (commercial land 1606 m² + land for public buildings 5889 m²). A detailed plan has been established for the entire property, according to which three purposes have been determined (commercial land 1606 m², residential land 3212 m² and land for public buildings 5889 m).

The property is large and has a nice green environment that helps create privacy.

A modern living environment has developed in this area, where the main necessary services are available. School, kindergarten, restaurant and Coop store. The residential area has good light traffic roads, playgrounds, a stadium and a skate park. An international hiking trail is nearby. Public transport stop within walking distance.

It is possible to purchase either:

1) the entire property (10,708 m²), where there is a residential building (with a tennis court, swimming pool, barbecue corner, and garage) and a functioning restaurant Mummi trahter, a sauna house, and an auxiliary building. Price: 800,000 euros. When buying the whole property, we can negotiate the price.

2) separate residential land (notional part as co-ownership), approx. 3451 m² (residential building, tennis court, garage, swimming pool, barbecue corner, access, etc.).

Residential building: 2-storey, closed net area 270.0 m² + balconies (9.7 m² + 2.9 m²) and outdoor terrace 41.9 m² + covered terrace 9.1 m². Year of construction 2007.

In total, according to the project, 7 rooms, 3 washrooms/wc (bath + shower), wood-burning sauna, fireplace room, kitchen-living room, cinema room, economy room and technical room.

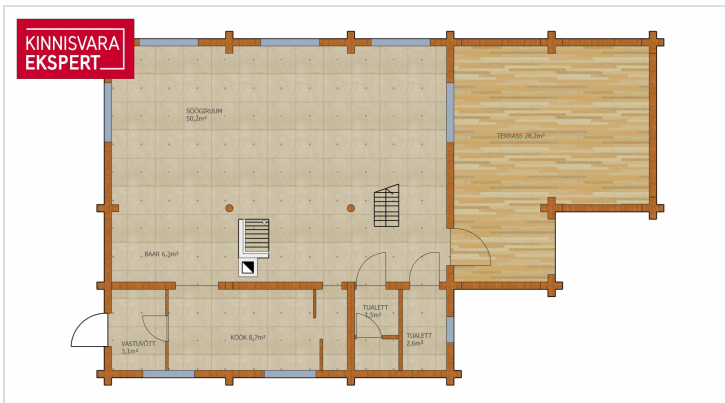
