For sale: The majority share (81%) of a residential-commercial building in the heart of Pärnu, which includes 5 apartment units with a total area of 443 m² (the building has 6 apartment units in total). The part for sale consists of office spaces on the basement, first, and second floors (total area 265 m²), a commercial space on the second floor (70 m²), and a two-story apartment on the third floor (108 m²). All spaces are rented with fixed-term leases, making this a suitable investment opportunity. It is also possible to purchase the entire property/building, including the third-floor apartment-office (102.6 m², spanning two levels), owned by a different party.

The office spaces (a total of 3 apartment units) are located in the basement (unit 1 / 94 m²), which contains staff rooms; on the first floor with street-facing display windows and direct access (unit 2 / 114.8 m²); and on the second floor, with office spaces accessible from the courtyard (unit 3 / 55.9 m²). The original use of the second-floor office space was residential, and it can be converted back into a two-room apartment. Lease agreement until 07/2026.

The commercial space on the second floor (unit 4 / 70.1 m²) is leased and used as a beauty salon, with access from the courtyard. The original use of this unit was residential, and it can be converted into a two- or three-room apartment. Lease agreement until 02/2029.

On the third floor, there is a three-room apartment with a rooftop terrace (unit 5 / 107.8 m²), spanning two floors. The first floor includes a spacious living room-kitchen, bedroom, bathroom-toilet, and sauna. The second floor has an additional open room. There is also access to a rooftop terrace with nice views of the Old Town. Lease agreement until 12/2024.
