The new 7-story apartment building being constructed at Tiiru Street 3 in the Valgre residential area is located by the sea, between the tennis hall and Hestia Hotel Strand, on the edge of the beach meadow. The south and west-facing balconies of the apartments offer the chance to enjoy stunning views and spend evenings with beautiful sunsets. The building's exterior design reflects Pärnu's image as a resort town—white exterior walls complemented by large glass-paneled sea-facing balconies, adding a sense of openness and lightness. The house will be completed as early as April 2025.

The building will feature 2-4 room apartments, each with a sea-view balcony or terrace. The apartments include underfloor heating, their own ventilation system, floor-to-ceiling windows in the sea-facing apartments, and "Premium" standard interior finishes. All apartments are equipped for air conditioning installation. The building includes an elevator and video surveillance. On the ground floor, there are storage units (available at an additional cost), an enclosed parking lot in the courtyard (parking space available at an additional cost, with electric charging readiness), a children's playground, and access to the sea-facing pedestrian path and promenade. The architects for the building are Hanno Grossschmidt, Tomomi Hayashi, and Siim Endrikson from the HGA architecture firm.

The sea-facing 3-room corner apartment No. 5 (82.4 m^2 + balcony 12.5 m^2) is located on the third floor of the building and offers views directly of the sea and beach meadow. The apartment features a spacious living room-kitchen (34.5 m^2), two bedrooms (16.5 m^2 ; 14 m^2), a shower room/WC (5.7 m^2), sauna (2 m^2), a hallway (7 m^2), and a separate WC. The sea-facing rooms have floor-to-ceiling sliding windows, providing access to the large south-facing balcony. The apartment's comfortable indoor climate is ensured by underfloor heating and heat recovery ventilation, with the option to add cooling for an additional fee.
